Other interests
Host dinner for Mr & Mrs Wei on 07/10/17 with all costs paid by myself in return for hospitality given during Nanning Sister City delegation. No considered a declarable item on this register but included in the interests of transparency following the lodgement of a controversial DA lodged for my Division in February 2018.
On 12th July 2018 I received a phone call from mr Sheng Wei, the proponent behind the Jewel Esplanade development application at Bargara and under assessment by BRC. He advised that he was bringing an associate from Nanning to Australia on 31 July 2018 who had interests in a company growing and processing fish and wanted him to meet me (as a shareholder of Abington Aquaculture). I advised him that the offer was inappropriate on a number of occasions and he then asked if I was interested in a fish processing factory. Again, I told him that the discussion was inappropriate, declined the offer and ended the call.
